Event Terms & Conditions

By attending any public event held at **Geneva Commons** (“Event”), you acknowledge and agree to the following Terms & Conditions:

1. Private Property

Geneva Commons is privately owned property. Attendance at Events is permitted only during designated event hours and in approved areas. Geneva Commons management reserves the right to deny entry, limit access, or require any individual to leave the property at any time for safety, security, or operational reasons. Admission may be limited due to room capacity

2. Assumption of Risk

By attending the Event, you voluntarily assume all risks associated with attendance, including but not limited to personal injury, illness, property damage, or loss that may occur on the premises. Attendance is at your own risk.

3. Children & Supervision

All children must be always accompanied and supervised by a parent or legal guardian. Geneva Commons, event organizers, sponsors, and vendors do not assume responsibility for the supervision of minors. Parents or guardians who do not wish their child to be photographed or recorded must notify Event staff upon arrival.

4. Code of Conduct

Guests are expected to behave in a respectful and lawful manner and comply with all posted signage and directions from Geneva Commons staff, security, or event personnel. Disruptive, unsafe, or disorderly behavior may result in removal from the property.

5. Liability Waiver

To the fullest extent permitted under Illinois law, attendees agree to release, indemnify, and hold harmless Geneva Commons, its owners, agents, tenants, event organizers, sponsors, vendors, employees, and contractors from any and all claims, liabilities, damages, losses, or expenses arising from or related to attendance at the Event, except for any liability that cannot be waived under Illinois law.

6. Photography & Videography

By entering the Event area, you acknowledge and agree that photographs, video, and/or audio recordings may be taken. You grant Geneva Commons and its partners permission to use your image, likeness, and/or voice for current and future marketing, advertising, promotional, public relations, and social media purposes, without compensation or further notice.

If you prefer not to be photographed or recorded, please notify Event staff upon arrival, and reasonable efforts will be made to accommodate your request. Giveaways, promotional items, food, merchandise or materials offered in connection with an event are available on a first-come, first-served basis while supplies last, and may be modified or discontinued at any time.

9. Raffles & Personal Information

Personal information collected through raffle entries or similar promotions may be used by Geneva Commons for future communications related to events, promotions, and programming. Personal information will not be sold or shared with third parties for their independent marketing purposes, and may be processed by authorized service providers, solely to deliver communications.

10. Personal Property

Attendees are responsible for their personal belongings. Geneva Commons is not responsible for lost, stolen, or damaged items.

11. Governing Law & Venue

These Terms & Conditions shall be governed by and construed in accordance with the laws of the **State of Illinois**, without regard to conflict-of-law principles. Any legal action arising out of attendance at an Event shall be brought in the appropriate state or federal courts located in **Kane County, Illinois**.

12. Acceptance of Terms

Attendance at any Event at Geneva Commons constitutes acceptance of these Terms & Conditions.
